The Bremer County Board of Supervisors met in session on Monday, May 13, 2019 in the Courthouse, Waverly, Iowa, at 10:00 a.m. Neil, Kammeyer and Hildebrandt present. Meeting was called to order by Chairman Neil, Hildebrandt moved/Kammeyer second to approve the agenda after removal of the Bremer County Fair Board update.

Neil moved/Hildebrandt second to open the Public Hearing for the Second Reading of Ordinance #19-04, 2018 International Building Codes, an ordinance amending the code of ordinances of Bremer County, Iowa, by repealing Chapter 1 of Title 5, thereof entitled Building Code and enacting and adopting a new Chapter 1 of Title 5 in lieu of entitled Building Code. Hildebrandt moved/ Kammeyer second to approve the second reading of Ordinance #19-04 2018 International Building Codes and set the date for the third reading to be 5/20/19 at 9:30 a.m.
